



Application for Certification Exemption

Pursuant to 8 VAC 40-31-120 (B) requires that all postsecondary school must become certified to operate prior to engaging in activities related to postsecondary education via telecommunications activity, mail correspondence courses, or at a location within the Commonwealth. Furthermore, all persons, training programs, degrees, diplomas, certificates or organizations offering training that leads to or enhances occupational qualifications must be certified to operate by the State Council of Higher Education for Virginia (SCHEV). Any violation of the provisions of § 23-276.12 of the Code of Virginia shall be punishable as a Class 1 misdemeanor.

<input type="checkbox"/>	<p>Any course or program of study conducted on a not-for-profit basis by firms or organizations for the training of their own employees only, provided that such instruction is offered at no charge to such employees and with no advertising for open enrollment.</p> <p>PROOF: To establish exemption under this section, the following evidence shall be submitted with your application:</p> <ul style="list-style-type: none"> • Name of program; • A notarized affidavit from the organization stating that no students other than employees will be solicited or enrolled. Further, stating that the employer will bear all the tuition costs and the employee will not be required to reimburse the employer by means of cash, production of work without pay, or any other means; and • Include samples of advertising that will be used by the employer within the business/organization to recruit participants. If there will be no advertising, just state so.

<input type="checkbox"/>	<p>Those courses offered and delivered by a postsecondary school that is accredited by an entity recognized by the U.S. Department of Education (USDOE) for accrediting purposes, if such courses are provided solely on a contractual basis for which no individual is charged tuition and for which no advertising has been made for open enrollment.</p> <p>PROOF: To establish exemption under this section, the following evidence shall be submitted with your application:</p> <ul style="list-style-type: none"> • Name of program; • A current copy of certificate, license, letter or other document showing approval of the school by an accrediting agency recognized by the U.S. Department of Education; • A notarized affidavit from the organization stating that courses are provided on a contractual basis and no tuition is collected from individual students (Note: contractual does <u>NOT</u> mean that the student pays the tuition and is reimbursed by the company); and • A notarized statement stating that no advertising will be made to solicit or enroll students.
<input type="checkbox"/>	<p>Any school, institute or course of instruction offered by any trade association or any nonprofit affiliate of a trade association on subjects related to the trade, business or profession represented by such association.</p> <p>PROOF: To establish exemption under this section, the following evidence shall be submitted with your application:</p> <ul style="list-style-type: none"> • Name of program; • A current copy of certificate, license, letter or other document showing approval of the school by the trade association or any nonprofit affiliate of a trade association; • A notarized affidavit from the training provider stating that no students other than members of the association will be solicited or enrolled.
	<p>Tutorial instruction delivered and designed to supplement regular classes for students enrolled in any public or private school or to prepare an individual for an examination for professional practice or higher education. {Example: GMAT, GRE, LSAT, CPA courses.}</p> <p>PROOF: To establish exemption under this section, the following evidence shall be submitted with your application:</p> <ul style="list-style-type: none"> • Name of course.
